Description Of Project:

The Wyoming Game and Fish Commission owns three important Wildlife Habitat Management Areas near Dubois, Wyoming: Whiskey Basin Wildlife Habitat Management Area, Inberg-Roy Wildlife Management Area, and Spence-Moriarity Wildlife Management Area. These areas include some of the most important crucial winter ranges for bighorn sheep, elk, and mule deer in the Lander WGFD Region. Cheatgrass has been found along many of the roads and disturbed sites across all three WHMA's. A herbicide treatment will be conducted to prevent the spread of cheatgrass from these disturbed areas into the important higher elevation sites used by wintering wildlife.

Problem to be Solved:

In 2016, the Fremont County Weed and Pest District conducted an inventory of cheatgrass on the Dubois Wildlife Habitat Management Areas. Cheatgrass was found prominently along many of the main roads within these areas. With wildlife migrations being a key component of all of these WHMA's, and the crucial winter range aspect of all of the grasslands on these units, this is particularly troubling. As wildlife move along roads, or disturbed sites, there is potential to spread cheatgrass into high priority habitat areas, which would be detrimental for wintering wildlife dependent on healthy grasslands. These areas are all prized for their bighorn sheep and elk herds.

Describe How You Propose Solving the Problem:

Cheatgrass will be aerially treated on approximately 800 acres using Plateau herbicide at a rate of 8 oz per acre in 5 gallons of water. Roads will be treated using a similar rate of herbicide, but utilizing a Fremont County Weed and Pest ground spray rig with a boom and hand guns. All of the main roads within the three Habitat Areas will be treated, amounting to approximately 30 miles of roads. Follow-up treatments will be anticipated every 2-3 years depending on results of post-treatment inventories.
